Fighting McCain/Feingold

Citizens United has teamed up with Congressman Ron Paul (R-TX) and several other conservative public policy organizations to file suit in Federal Court to strike down the unconstitutional McCain/Feingold campaign

finance reform law. Several months ago, CU joined 55 other conservative groups cosigning letters to both the U.S. Senate and President Bush denouncing the unconstitutionality of this law. The McCain/Feingold law tramples on our First Amendment freedoms in an effort by career Washington politicians to prevent individuals

and public policy groups from challenging entrenched politicians. McCain/Feingold would ban issue advertising by Citizens United and all other advocacy groups in future election cycles.

authored by CU President David N. Bossie and Senior Policy Analyst Christopher M. Gray.

- Al-Qaeda's Revenge: Its Methods and Nation-State Allies, also authored by Bossie and Gray, studies how this Radical Muslim terrorist network recruits its members, conducts its secret operations and quietly receives support and sanctuary from allied countries. Al-Qaeda's Revenge also suggests a strategy for America to wage war against the terror network.
- *Bio-War: America's Greatest Current Threat* analyzes the dangers of bio-terrorism and how we can prepare for and prevent an incident. Mary Beth Brown, a Registered Nurse and Director of the American Medical Commission, wrote this well researched policy paper.
- Terror Attacks on America: A Wake-Up Call for Immigration and Border Control Reform studies America's lax policies of immigration and border control and how they allowed Al-Qaeda terrorists to wreak havoc on the United States. Authored by Citizens United General Counsel and Director of the American Sovereignty Action Project, Michael Boos, Terror Attacks on America explains how our

immigration and border policies went wrong and what can be done to fix them.

- Military Trials for Al-Qaeda Terrorists & Their Taliban Sponsors are Constitutionally Sound and Consistent with American Interests analyzes President Bush's proposal to try terrorists using military tribunals. Authored by Michael Boos and David Bossie, this paper demonstrates that military tribunals are a valid and effective method for trying captured terrorists.
- Blame America First, Again: The Campus Left Reacts to the War on Terror also authored by Bossie and Gray demonstrates how college professors are leading the opposition to the War on Terror on college campuses.

The CU staff makes frequent television and radio appearances on issues related to the War on Terror and other important public policy issues. A partial list is on page 8 of this newsletter. David Bossie has also authored several op-eds including a review of Democratic Senate Majority Leader Tom Daschle, called 'Driving Mr. Daschle,' that appeared in the March 21, 2002 Washington Times editorial page.

Lobbying Congress

One of the first major projects we took on was "Citizens United to Defeat D.C. Statehood." The campaign for D.C. statehood was being led by

Jesse Jackson and other Leftist Democrats. Citizens United's then-President Floyd Brown testified before Congress opposing the statehood bill. We organized a 'letters to the editor' campaign which resulted in hundreds of local newspapers nationwide publishing the Citizens United-inspired letters. We also delivered millions of petitions to Congress opposing D.C. statehood.

In 1991, Citizens United championed Clarence Thomas' nomination to the U.S. Supreme Court. The highlight of the effort was an effective television

commercial entitled *Who Will Judge the Judge?* comparing Thomas' exemplary record to that of liberal Senators Ted Kennedy, Joe Biden, and Alan Cranston. The television ad ran nationally and helped sway public opinion to support

Clarence Thomas' confirmation as a Supreme Court Justice.


Investigating Bill Clinton

David Bossie joined the Citizens United staff in 1992 as its Political Director. During that year's Democrat Presidential primaries, CU undertook the task of educating the American people about Bill Clinton's record as Governor of Arkansas. Citizens United published a best-selling biography of Bill Clinton, SLICK WILLIE: WHY AMERICA CANNOT TRUST BILL

CLINTON (AnnapolisWashington Publishing, 1992),
exploring his record as Arkansas
Governor, his unconstitutional
abuses of power and the policies

he would institute if elected President. **SLICK WILLIE** introduced America to the Whitewater land development scandal and exposed Bill and Hillary Clinton.

Citizens United began publishing our monthly investigative newsletter, *Clinton Watch*, detailing Bill and Hillary Clinton's ethical problems and violations of the law.

Floyd Brown's radio talk show, *Talk Back Live* that ran from 1994-1995, was also part of Citizens United's mission. The nationally syndicated show discussed important topics of the day and took phone calls from across the country.

Later, Floyd and Kirby Wilbur, a Seattle talk radio host and former CU Director, compiled and published a book containing the best quotes from their favorite political, religious and intellectual leaders entitled **SAY THE RIGHT THING** (Merril Press, 1999).

Whitewater

Throughout the 1990's Citizens United's Political and Communications Director David Bossie, now Citizens United's President, effectively tracked down and exposed Bill and Hillary Clinton's many illegal and unethical activities. Bossie's research helped the news media learn of and understand the Whitewater scandal. CU also published a policy paper to explain the complex business scheme known as the Whitewater Development Corporation. Bossie's investigative work with television and newspaper reporters from The New York Times, ABC News, The Washington Post, and many others began in 1993. His effectiveness in investigations and dealing with the media was discussed extensively in former Wall Street Journal editor James Stewart's best-selling book on Whitewater, BLOODSPORT (Simon & Schuster, 1996).

As a strong supporter of personal freedom, Congressman Toomey voted against the

Campaign Finance Reform bill and received the grade of 'A' from the National Taxpayers Union in its recent Congressional Voting Record Analysis.

More importantly, Bossie's research on Whitewater helped spark Congress to renew the Independent Counsel Statute. Both Special Prosecutor Robert Fiske and Independent Counsel Kenneth Starr were appointed because of David's dogged investigations of the Whitewater paper trail.

David Bossie left Citizens United early in 1995 to assist U.S. Senator Lauch Faircloth (R-NC), a member of the special Senate Whitewater Committee to investigate this scandal. David's investigation for Senator Faircloth, based on his time at Citizens United, was instrumental in educating the American people about Bill and Hillary Clinton's character and ethics in Arkansas and the White House. The Senate hearings assisted Independent Counsel Kenneth Starr in indicting and convicting in Federal Court Arkansas Governor Jim Guy Tucker, Clinton partners Jim and Susan McDougal,

Webster Hubbell and other prominent Whitewater figures.

Illegal Foreign Money for Missile Technology

Following the Senate Whitewater investigation, David Bossie moved over to the House of Representatives to serve as Chief Investigator of the House Government Reform and Oversight Committee. Under the Committee's Chairman Dan Burton, (R-IN), David discovered and publicized the Clinton-Gore Administration's Chinese fundraising scandal.

David uncovered how Bill Clinton and Al Gore allowed front men for the

People's Republic of China's intelligence agencies to pump illegal foreign money into the 1996 Clinton-Gore re-election campaign in return for White House and Administration access. Chinese intelligence officials and their straw donors were allowed into the White House; some donors were invited to stay overnight in the Lincoln Bedroom. Bossie exposed the now infamous Buddhist Temple fundraiser in California and other money laundering schemes used to disguise illegal Communist Chinese money coming into the Clinton-Gore campaign. Based on this investigation, dozens of individuals pled guilty or were convicted of violating Federal campaign finance laws. Hundreds of others fled the country or pled the 5th amendment and refused to testify.

David Bossie also led the investigation into Janet Reno's corrupt Justice Department and unearthed how convicted Clinton buddy Webb Hubbell was paid hush money from friends of Bill and Hillary Clinton.

Meanwhile, Citizens United was doing its part to uncover and expose Bill Clinton's perjury and obstruction of justice in the Whitewater trial of Jim McDougal. Efforts included a two-year legal battle to make Bill Clinton's videotaped testimony in the criminal trial available to the public. Later, Citizens United brought a Freedom of Information Act lawsuit against Janet Reno, which ultimately forced her office to release records of the Clinton Justice Department's politically motivated surveillance of Citizens United.

After Bossie left his post as Chief Investigator in 1998, he rejoined Citizens United and Citizens United Foundation. He

established *The Center for Government Integrity* whose mission is to conduct research on ethics in government and report about corruption and abuses of power to the American people.

Recently, *The American Medical Commission* was established by Mary Beth Brown, R.N. to fight against Health Care policy designed to bring about socialized medicine in America.

Investigating Al Gore

Once Bossie and Brown were a team again, they continued their investigations of the Clinton-Gore

Administration. They drafted early Articles of Impeachment and forwarded them to the House Judiciary Committee and conducted petition drives and media appearances to educate the American people about the Clintons. These efforts helped to impeach Bill Clinton for his perjury and obstruction of justice in December 1998.

In 1999, David and Floyd produced a thirtyminute video detailing the campaign finance lawbreaking by the

Clinton-Gore Administration entitled *Bill Clinton, Al Gore, and the Communist Chinese Connection*. This hard-hitting investigative video detailed the illegal activity of the Clinton-Gore Administration and the millions of dollars of illegal Chinese money flowing into the campaign. For his dedication to uncovering the truth about Bill Clinton and fighting for the conservative movement, David Bossie was presented with the prestigious *Ronald Reagan Award* at the 1999 CPAC Conference.

Bossie and Brown then turned their attention to the 2000 Presidential Campaign. They worked with Christopher Gray, now Citizens United's Senior Policy Analyst, to research and write a candid biography of Al Gore entitled **PRINCE**ALBERT: THE LIFE AND LIES OF AL GORE (Merril Press, 2000), featuring a foreword by conservative columnist Robert

Novak who praised the quality and accuracy of the book authors' research and writing. **PRINCE ALBERT** told the unvarnished truth about Al Gore and didn't pull any punches.

Citizens United's leaders did not just write about Al Gore. They were active in various roles in the campaign. Floyd Brown served as a Washington State delegate to the 2000 Republican National Convention in Philadelphia, just as he had at the 1996 Republican Convention in San Diego. Citizens United's Vice President and General Counsel Michael Boos served

on the 2000 Committee for a Conservative Platform. Both Bossie and Brown completed a national book tour and participated in numerous television, radio and media interviews for **PRINCE** ALBERT. They also hosted a reception honoring Chairman Dan Burton at the Republican National Convention in Philadelphia. The 500person reception included Bob Barr, Henry Hyde, and Phyllis Schlafly.

Shortly after the Supreme Court upheld

George W. Bush's 2000 Presidential victory, Floyd Brown stepped down as Citizens United's President to become Executive Director of Young America's Foundation. Brown continues to serve as Chairman of Citizens United's Board of Directors.

Supporting President Bush

David Bossie succeeded Floyd Brown as President of Citizens United. Bossie's first major effort was to create a new project to assist President Bush's legislative agenda, *Citizens United for the Bush Agenda*. Its goal is to empower Citizens United members to help President Bush enact key elements of his conservative plan including winning the War on Terror, permanent across the board tax cuts, abolition of the death tax, a strong national defense, deployment of a missile defense system, choice in education and deregulation.

Citizens United Foundation Impacts Public Policy

Public Policy Research and Communications

Citizens United Foundation (CUF) was established in 1992 as a tax-exempt research and educational organization with a mission of grassroots education about issues important to the future of a free nation. One of CUF's first major undertakings included a series of amicus briefs supporting the constitutionality of congressional term limits.

The American Sovereignty Action
Project (ASAP) and the National Citizens
Legal Network (NCLN) were created in
1995 as projects of Citizens United
Foundation. ASAP's first director was Cliff
Kincaid, a noted researcher and journalist.
NCLN's first director was Michael Boos,
who currently serves as Vice President and
General Counsel of Citizens United and
Citizens United Foundation.

ASAP is a grassroots educational organization fighting to protect American sovereignty and security from leftist world government and globalization projects hatched by the United Nations. ASAP regularly publishes public policy papers and articles on timely issues relating to sovereignty and the threats posed by the United Nations. Examples include a special report on the 50th anniversary of the U.N., A Matter of Sovereignty: Why the U.S. Owes Nothing to the U.N. and Al Gore, the United Nations, and the Cult of Gaia.

In 1997, ASAP produced and distributed a video documentary entitled *Sinister*

Secrets of the United Nations. ASAP has also sponsored Washington, D.C. seminars for congressional staff regarding the evils of the U.N. and a one world government. ASAP's staff routinely participates in public policy debates and

appears on radio and television programs to discuss the U.N., the War on Terror, and sovereignty and security issues.

Courtroom Advocacy

NCLN works to fulfill Citizens United Foundation's mission by focusing on issues related to constitutional law, the original intent of the Founding Fathers, the overall process of government, and the containment of federal regulatory power. Early

NCLN activities included a challenge to a minority set-aside scheme involving the sale of Viacom cable systems to a purported minority owned investor. This investor would have received a \$500 million tax credit if the deal had gone through. NCLN also published an in-depth study questioning the constitutionality of the Federal "assault weapons" ban.

NCLN is a strong courtroom advocate of conservative values. When the Clinton Administration attempted to manipulate congressional reapportionment by interjecting statistical sampling into the

2000 census, NCLN joined with other conservative groups in challenging the scheme. The effort culminated in a landmark victory before the U.S. Supreme Court in *U.S. House of Representatives v.*

U.S. Department of
Commerce. Later, in Boy
Scouts of America v. Dale,
NCLN co-sponsored a
U.S. Supreme Court brief
that helped to vindicate
the right of the Boy Scouts
to exclude homosexuals
from the ranks of the
organization's
scoutmasters.

As a stalwart defender of free speech, privacy and other rights, NCLN participates in court cases and appears before various regulatory agencies such

as the Federal Election Commission,
Federal Communications Commission,
Federal Deposit Insurance Corporation and
National Highway Traffic Safety
Administration. NCLN's briefs and legal
analysis helped to dismantle regulations
designed to impose a federal ID system and
helped kill the Clinton-proposed "know
your customer" banking rules.

ASAP and NCLN frequently coordinate activities. For example, the two projects rushed to the aid of Army Specialist, Michael New, when he refused to obey orders of the extra-constitutional United Nations Command while serving in Macedonia in 1997. The efforts for Michael New included two amicus briefs before the U.S. Supreme Court. ASAP and NCLN also joined forces in fighting the implementation of the United Nations International Criminal Court (ICC). ASAP and NCLN representatives have debated the ICC's proponents, rallied opposition to the treaty on Capitol Hill and written extensively on the dangers posed by the
